I am a United States citizen, or in resident alien status, as defined by the United States citizenship and immigration services laws and regulations.			
I am a high school graduate, have a high school equivalency diploma, or have a GED certificate.			
I have not plead guilty to, plead nolo contendere to, or have been found guilty, in any state or federal court, of a felony offense.			
I have not plead guilty to, plead nolo contendere to, or have been convicted in any state or federal court of offenses involving moral turpitude, sexual violations, domestic violence, violation of a domestic violence restraining order, child abuse or neglect, firearms under North Dakota Century Code title 12.1 or 62.1 or any other criminal offense the board determines has a direct bearing on the applicant's or licensee's ability to serve as a peace officer.			
I am not prohibited from using or possessing a firearm.			
I have a valid driver's license issued in the United States.			
I have undergone a criminal history background investigation by the employing agency and have fingerprint clearance from the North Dakota Bureau of Criminal Investigation and the United State Department of Justice Federal Bureau of Investigation.			
I have passed a medical examination and psychological examination. The psychological examination was administered by a board approved psychological provider. Only physicians, osteopathic physicians, nurse practitioners, and physician assistants are authorized to administer medical examinations for the board. The psychological and medical examinations remain valid for one year from the examination date.
